With or without reasonable accommodation this person must have the ability to successfully accomplish the following, including but not limited to:

## **Essential Functions and Tasks:**

- A. Essential Function Performs support functions. Essential Tasks:
- 1. Clean and maintain Department vehicles.
- 2. Schedule and document necessary vehicle maintenance and repairs on Department vehicles and equipment.
- 3. Clean and maintain Department facilities and grounds.
- 4. Monitor and coordinate maintenance of the elevator, generator, sump pump, basement sewer valve and fire extinguishers.
- 5. Participate in searches for missing persons.
- 6. Operate, emplace and retrieve animal traps.
- 7. Locate, capture and transport animals running at large.
- 8. Extinguish small fires using a fire extinguisher.
- 9. Mark vehicle tires to determine potential parking violations.
- 10. Direct traffic.
- 11. Remove debris from Department grounds, vehicles and facilities.
- B. Essential Function Exercises ethics. Essential Tasks:
- 1. Exercise discretion in selecting appropriate enforcement action.
- 2. Apply ethical standards while performing community service duties.
- 3. Recognize and report misconduct of other employees.
- 4. Enforce professional standards among colleagues.
- 5. Use proper judgment when confronted with offers of gratuity (i.e., free drinks, meals, services, etc.)
- 6. Recognize potential ethical problems related to use of social media.
- 7. Recognize and maintain confidential and sensitive information on and off duty.
- C. Essential Function Conducts Investigations. Essential Tasks:
- 1. Conduct nuisance property investigations.
- 2. Recognize and properly handle potential evidence related to code and other violations.
- 3. Make field contacts to obtain information.

- 4. Review records and pictures to identify vehicle and property owners, residents, etc.
- 5. Review the assessor's property records to determine property ownership.

## D. Essential Function – Prepares and presents evidence and testimony. Essential Tasks:

- 1. Identify elements of code violations to ensure proper charges.
- 2. Present evidence and testimony in legal and/or administrative proceedings (e.g., nuisance hearings, trials, etc.).
- 3. Prepare visual aids for nuisance hearings (e.g., photos, PowerPoint slides, etc.).
- 4. Read/Review case reports and notes to prepare for court testimony.
- E. Essential Function Assist officers with traffic control and removal of vehicles. Essential Tasks:
- 1. Control traffic at traffic accident scene or the perimeter of an incident or special event.
- 2. Follow state statutes and Department procedures to impound vehicles.
- 3. Assess need for and organize assistance for motor vehicle crashes or disabled vehicles (e.g., wrecker, sand truck).
- F. Essential Function Provides first aid and emergency assistance. Essential Tasks:
- 1. Apply basic first aid.
- 2. Administer CPR to an adult, child or infant.
- 3. Use personal protective equipment (e.g., gloves, masks, glasses, etc.) to prevent contact with communicable diseases.
- 4. Apply a tourniquet.
- G. Essential Function Practices positive human relations. Essential Tasks:
- 1. Use verbal de-escalation techniques to communicate with person.
- 2. Use voice and words to calm a situation, project intention, etc.
- 3. Speak confidently to project control, self-assurance, etc.
- 4. Speak plainly/clearly to encourage understanding.
- 5. Use and adjust language appropriate to listener.
- 6. Maintain concentration while many people speak simultaneously.
- 7. Maintain personal calm to prevent making situation worse.
- 8. Use body language to project control and influence situation.
- 9. Advise a person of nuisance property and other city processes.
- 10. Verbally communicate past observations, experiences, events, and incidents.
- 11. Communicate effectively orally and in writing, in diverse situations.
- H. Essential Function Operates City Vehicle. Essential Tasks:

- 1. Operate city vehicle in heavy rain, at night or in limited visibility.
- 2. Operate city vehicle on dirt, gravel or ice/snow covered road.
- 3. Inspect city vehicle for defects, maintenance issues and proper equipment.
- I. Essential Function Writes Reports. Essential Tasks:
- 1. Complete in-depth narrative reports containing complete sentences and paragraphs (e.g., investigative reports, supplemental/follow-up reports)
- 2. Complete reports using appropriate grammar, spelling, punctuation, word use, coding, formatting, symbols, and mathematical computations.
- 3. Complete reports consisting primarily of check-off boxes or fill-in blanks. (e.g., incident report, nuisance tracking forms, property forms, etc.)
- 4. Complete parking citations.
- 5. Write personal field notes to record actions, interviews, etc.
- 6. Summarize in writing the statements of witnesses and complainants.
- 7. Review photographs.
- J. Essential Function Use of specialized equipment. Essential Tasks:
- 1. Use/operate City vehicle.
- 2. Don/Doff personal protective equipment.
- 3. Use first aid kit.
- 4. Use battery operated road warning signals.
- 5. Carry/Use large and/or small flashlight
- 6. Operate portable police radio (i.e., walkie-talkie).
- 7. Operate City vehicle radio equipment.
- 8. Operate City vehicle warning lights and spotlights.
- 9. Don/Doff reflective vest.
- 10. Use a traffic wand.
- 11. Don/Doff protective gloves.
- 12. Operate video/audio recording equipment.
- 13. Operate a digital camera.
- 14. Operate an automated external defibrillator (AED) device.
- 15. Operate a personal computer (PC).
- 16. Operate a telephone.
- 17. Operate a copier, scanner and/or FAX machine.

- 18. Operate a push mower.
- 19. Operate a riding lawn mower.
- 20. Operate a leaf blower.
- 21. Operate a weed trimmer.
- 22. Operate a snow thrower.
- 23. Use a snow shovel.
- 24. Operate a fertilizer spreader.
- 25. Operate a weed sprayer.
- 26. Operate common hand tools (hammer, screwdrivers, sockets, wrenches, etc.)
- 27. Operate an animal live trap.
- 28. Operate an animal catch pole.
- 29. Use a step and/or extension ladder.
- K. Essential Function Technical Information. Essential Tasks:
- 1. Read and comprehend City codes and ordinances.
- 2. Read and comprehend applicable State laws.
- 3. Read and comprehend City and Department rules and regulations, policies and procedures, bulletins and operations manuals.
- 4. Read and comprehend operating and safety manuals of community service devices.
- 5. Read and comprehend road signs, controls and markings.
- L. Essential Function Exercises judgment. Essential Tasks:
- 1. Exercise independent judgment to determine when a code violation exists.
- 2. Independently prioritize simultaneous requests, expectations, tasks, and actions.
- 3. Exercise independent decision-making during high-stress and other situations.
- M. Essential Function Physical abilities. Essential Tasks:
- 1. Walk on irregular, potentially hazardous surfaces (e.g., slick, wet, muddy, swampy, rocky, etc.).
- 2. Identify and navigate past hazards (e.g., ditch, hole, etc.).
- 3. Kneel, squat and recover to feet.
- 4. Perform repetitive hand movement (e.g., keyboarding, traffic control, etc.) for up to one hour per day.
- 5. Work in a confined, closed-in area (e.g., vehicle, desk, cubicle).
- 6. Stand for more than 2 hours of work shift.
- 7. Walk for more than 2 hours of work shift.

- 8. Sit for more than 2 hours of work shift.
- 9. Climb stairs in multiple story buildings.
- 10. Cope with the emotional and physical results of being struck by or exposed to bodily fluids.
- 11. Cope with the emotional and physical impact of being subjected to verbal abuse and/or threats of violence.
- 12. Cope with the emotional and physical impact of being exposed to traumatic incidents.
- 13. Cope with the physical effects of shift-work.
- N. Essential Function Degrees of physical exertion. Essential Tasks:
- 1. Walk continuously Maximum time 1 hour.
- 2. Stand continuously Maximum time 4 hours.
- 3. Walk up/down stairs Maximum 2 flights.
- 4. Sit continuously (e.g., office, vehicle operation, etc.) Maximum time 3 hours.
- 5. Lift objects up off the ground without assistance Maximum lift-height in inches 36 in Maximum weight of object 40 pounds.
- 6. Lift objects up off the ground with assistance Maximum lift-height in inches 36 in Maximum weight of object 200 pounds.
- 7. Use repetitive hand motions/movements (e.g., keyboard, traffic control, etc.) Maximum time 45 minutes.

## Working Conditions:

- 1. Work rotating, odd, extended, daytime, evening and overnight shifts including weekends and holidays.
- 2. On-call 24 hours.
- 3. Work in approved uniform.
- 4. Work in an office setting.
- 5. Work outdoors, on highways and City streets, in and out of a vehicle.
- 6. Exposed to hazardous chemicals.
- 7. Exposed to hazardous equipment.
- 8. Performs other functions that may be assigned at the discretion of lawful authorities.
