**Permit Requirements:**

- All debris removal and final grading is to be completed within **30 days** of the demolition of the structure.
- You must get prior approval from the Public Works Director. All utilities must be abandoned, **capped** and locations recorded. You must contact the Department of Public Works before these services are buried. Call 826-4312 for the Utility Department.
- \$1000.00 "**Hold Harmless Bond**" to the City of Crete is required from the demolition contractor.
- Certificate of Insurance** - \$100,000. B.I. \$300,000. P.D. minimums to City of Crete required from the demolition contractor.

- It shall be the duty of the applicant to cause the demolition site to be protected by erecting suitable **guards, barricades, or fencing** to contain and isolate debris, open basements, excavations, and/or partially demolished structures which may have their structural integrity compromised. **Warning signs** shall be posted on all outward facing sides of the barriers.
- If your home was built before 1981, OSHA requires worker protection when removing presumed (suspect) asbestos containing building materials in all structures. More information located on back of this document.

## **Asbestos where is the hazard?**

The hazard may occur during renovating or demolishing buildings or cleanup from those activities and having contact with deteriorating asbestos-containing materials during *cleanup after natural disasters*.

Some materials are presumed to contain asbestos if installed before 1981. Examples of these materials, as well as other presumed asbestos-containing materials are:

- Thermal system insulation
- Roofing, siding and shingles
- Vinyl floor tiles
- Plaster, cement, putties and caulk
- Ceiling tiles and spray-on coatings
- Industrial pipe wrapping
- Heat-resistant textiles
- Automobile brake linings and clutch pad

## ***Construction Contractors:***

### Asbestos

- Contractors must obtain a written asbestos report from the building owner prior to bidding or starting any work.
- Asbestos report must be provided to any sub-contractors involved in the project as well.
- Any employees on the job site must be notified about any asbestos materials that they may come into contact with.
- Make sure a Certified Asbestos Contractor handles any asbestos materials that need to be removed or disturbed.
