Applicant must be a registered Master Plumber with the City of Crete. Rough in and final inspection required for occupancy. Work must conform to the 2018 UPC with local Amendments and City ordinances. Non-Metallic water lines buried need tracer wire. Install shutoffs on each side of meters. Backflow devices must be submitted for approval, Crete maintains a list of Approved Backflow Preventers. The fee for engaging in any activity that requires a permit from the Building Department or Public works Dept. Prior to the application and receipt of such permit shall be 1% of regular fee or \$100 which ever is greater.
