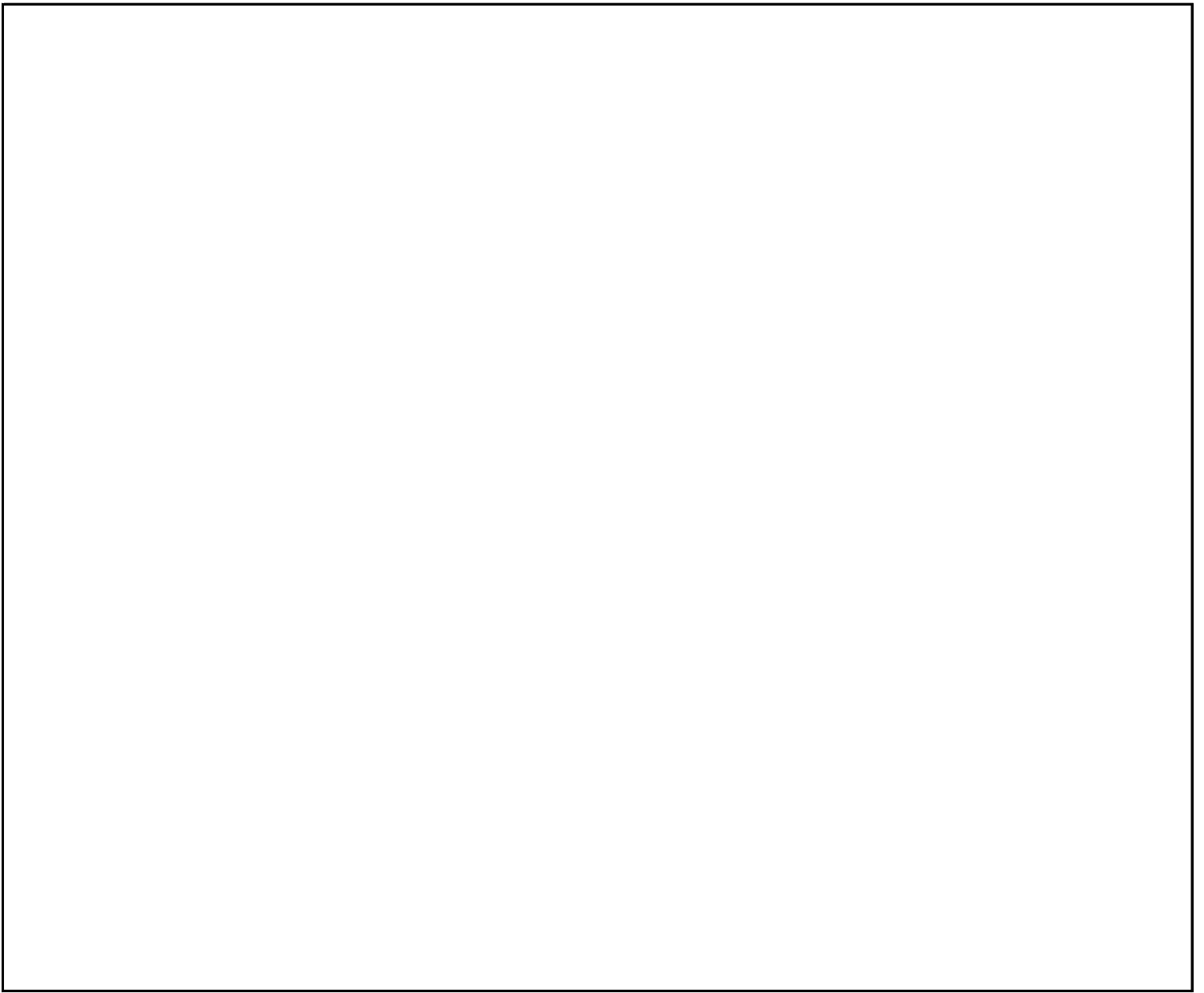

Applicant must be a registered Master Plumber with the City of Crete. Rough-in work must be inspected before concealed. Final inspection required before occupancy permit will be issued. Work must conform to the 2009 Uniform Plumbing Code with local Amendments and City ordinances. A copy of Plumbers registration must be filed with the city per city code 9-709, also must provide a valid certificate of insurance and post a \$3,000 performance bond. Non-metallic water lines buried need tracer wires. Install shutoffs on each side of meters. Backflow devices must be submitted in advance for approval, the City maintains a list of USC Approved Backflow Preventers.
